The NEA-NM Education Political Action Committee (EdPac) collects voluntary contributions from Association members and uses those contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of education who are candidates for elected office. Contributions to EdPac are voluntary; making a contribution is neither a condition of employment nor membership in the association, and members have the right to refuse to contribute without suffering any reprisal. A voluntary contribution of six dollars (\$6.00) for Certified (or \$3.00 from Classified members) is included in your total annual dues obligation amount and will be collected in the same manner as dues. This voluntary contribution may be refunded to members who request it according to procedures contained in the NEA-NM by-laws. Forms for requesting the refund are available on www.nea-nm.org and are published twice annually in the *Advocate's Voice*. EdPac contributions are not deductible as charitable contributions for federal income tax purposes.
